# UCI Logistics Pension Scheme (the Scheme)

## **Statement of Investment Principles**

November 2024

## Introduction

This statement has been drafted to record the Trustees' investment principles and to provide details of the investment strategy adopted for the Scheme.

In preparing this statement, the Trustees received advice from their Investment Adviser (First Actuarial LLP) and have consulted with the sponsoring employer. The Trustees have considered the legislative requirements regarding the production of a Statement of Investment Principles, in particular, consideration has been given to:

- the Pensions Act 1995
- the Occupational Pensions (Investment) Regulations 2005
- the Pension Protection Fund (Pensionable Service) and Occupational Pension Schemes (Investment and Disclosure) (Amendment and Modification) Regulations 2018
- the Occupational Pension Schemes (Investment and Disclosure) (Amendment) Regulations 2019.

The Trustees have also considered The Pension Regulator's guidance with regard to the contents of a Statement of Investment Principles.

However, following the purchase of a bulk annuity policy through which all of the Scheme's liabilities have been insured, the Scheme's investment strategy is very simple and responsibility for the day-to-day investment of the vast majority of the Scheme's assets has been delegated to the insurer providing the bulk annuity policy. Accordingly, the Trustees have concluded that this statement only needs to be brief.

### **Investment Strategy**

The Trustees have invested in a bulk annuity policy provided by Aviva Life and Pensions UK Ltd (Aviva). This insurance policy provides income which is expected to fully cover the future benefit payments due to all members of the Scheme.

The Trustees may also hold cash in the Trustees' bank account.

The investment strategy is expected to ensure that all members will receive the benefits to which they are entitled as those benefits fall due.

#### **Environmental Social and Governance considerations**

Since the Scheme's assets are invested entirely in an insurance policy and cash, the Trustees do not consider ESG risks to be material for the Scheme.

#### Stewardship

The Scheme does not invest in equities and therefore there are no voting rights associated with the Scheme's investments.

#### **Non-financial matters**

Legislation defines non-financial matters as meaning the views of the members and beneficiaries including (but not limited to) ESG matters and the present and future quality of life of the members and beneficiaries of the Scheme.

The Trustees do not expect to make future changes to the Scheme's investment strategy, other than to secure benefits on an individual basis with Aviva, at the point the Scheme is wound up. The Trustees are of the view that the approach adopted is in members' best interests.

#### Monitoring

Under the terms of the contract, the Trustees have delegated responsibility for meeting members' benefit payments to the insurer. The Trustees undertook due diligence and received legal advice on the appropriateness of the insurer as an ongoing benefit provider. The Trustees therefore do not expect to carry out ongoing monitoring of the Scheme's investments.

## **Additional Voluntary Contributions**

Additional Voluntary Contributions (AVCs) are held separately from the Scheme's other investments and will be used to secure benefits on a money purchase basis for members at retirement. The Scheme's AVC arrangements are held with Utmost. From time to time the Trustees review the ongoing suitability of the AVC arrangements.

## Risks

The nature of the Scheme's investment strategy means that the Trustees consider the investment risks to have been effectively mitigated. This means that there is a high likelihood of all members receiving their benefits in full as they fall due.

One risk that remains is the risk of the insurer defaulting on the payments due under the terms of the bulk annuity policy. This risk is mitigated by the legislative framework under which the insurer operates, and the reserves held by the insurer.

## **Future Amendments**

The Trustees will review this statement at least every three years and without delay after any significant change in circumstances or investment strategy.

The Trustees will consult with the sponsoring employer before amending this statement.

The Trustees will obtain and consider written advice from the Investment Adviser before amending this statement.
